- 2.6 Q.R Code bear the details of the company that manufacture it, the agency that market it, the material specification, date of manufacture, batch No., CPCB approval details with license No. and validity and SPCB registration certificate shall be printed on the product. The details of the QR code shall be shared with the SPCB within 30 days of the receipt of this certificate.
- 2.7 The product shall dissolve in Dichloromethane (Methylene dichloride) and this shall be indicated in the garbage bag, as a preliminary test for identification. This shall be printed on the product as 'This product dissolve in Dichloromethane (Methylene dichloride)
- 2.8 The application for renewal of Registration shall be submitted one month before expiry of the registration.
- 2.9 The validity of this registration is subjected to the validity of certificate from Central Pollution Control Board by the manufacture for marketing and selling and on compliance of conditions in the registration and of the provision of Plastic Waste Management Rules, 2018, amendment thereon and subject to the judgement dated 16.10.2021 in W.P.(C) No.4291/2020, and on intra court appeal if any by the Government.
